**PERSONAL DATA PROCESSING OF HALAS 71 CUSTOMERS**

Your personal data may be processed by İltur Gemicilik ve Yat İşletmeleri Sanayi Ticaret Anonim Şirketi (“**Company**”) as the data controller in accordance with the Personal Data Protection Law No. 6698 (“**Law**”) within the scope specified below.

**Purposes for and Legal Grounds of Processing Personal Data**

Your collected personal data may be processed by our Company within the conditions and purposes for the processing of personal data specified in Article 5 of the Law, for the following purposes (“**Purposes**”).

***Bir sözleşmenin kurulması veya ifasıyla doğrudan doğruya ilgili olması kaydıyla, sözleşmenin taraflarına ait kişisel verilerin işlenmesinin gerekli olması hukuki sebebine dayanarak;***

- Performing our obligations arising from the service contract,
- Receiving payments for our services from you electronically,
- Carrying out the necessary work and related business processes in order to benefit from the services offered by the Company.

***Based on the legal ground that it is expressly provided for by the laws and is necessary for compliance with a legal obligation to which the data controller is subject;***

- Fulfilling the requests of official authorities,
- Providing information to the competent official authorities pursuant to the legislation,
- Ensuring compliance with the storage obligations stipulated in the legislation,
- Responding to data subject applications in accordance with the legislation and taking necessary actions.

***Based on the legal ground that data processing is necessary for the establishment, exercise or protection of any right;***

- Storing personal data during the general statute of limitations in order to provide evidence in possible future disputes.

***Based on the legal ground that processing of data is necessary for the legitimate interests pursued by the data controller, provided that this processing shall not violate the fundamental rights and freedoms of the data subject;***

- Follow-up of financial and accounting operations,
- Managing information security processes.

**Recipient Parties and Purposes for Transferring Personal Data**

Your personal data may be transferred for the Purposes to our suppliers, business partners within the scope of our legitimate interest; legally authorized public authorities and legally authorized private institutions within the scope of that is expressly provided in the laws and fulfillment of our legal obligations pursuant to the data processing conditions stipulated in Article 5 of the Law and in accordance with the rules regarding the transfer of personal data specified in Article 8 of the Law.

**Method of the Collection of Personal Data**

Your personal data may be collected electronically via online payment form or e-mail for the above-mentioned Purposes.

**Data Subject's Rights Specified under Article 11 of the Law**

We hereby declare that you are entitled to the following rights, regarding your personal data, set forth under Article 11 of the Law:

- To learn whether your personal data are being processed,

- To request information if your personal data have been processed,
- To learn the purpose of the processing of your personal data and whether they have been used accordingly,
- To learn which third parties domestic or abroad your personal data has been transferred to,
- To request rectification in case your personal data has been processed incompletely or inaccurately and to demand the operations in this regard be reported to third parties your personal data has been transferred to,
- To demand the erasure or destruction of your personal data in the event that the reasons for the processing no longer exist even though it was processed in accordance with the Law and other relevant provisions and to demand the operations in this regard be reported to third parties your personal data has been transferred to,
- To object to negative consequences to you that are concluded, as a result of analysis of the processed personal data through solely automatic systems,
- To demand compensation for the damages that you have suffered as a result of an unlawful processing of your personal data.
